

Voters to decide on \$28.5 million budget for 2022-23 school year

Proposed budget maintains programming; tax levy under 'cap'

On Tuesday, May 17, Stillwater Central School District residents will vote on a proposed \$28,544,605 budget for the 2022-23 school year. The spending plan preserves existing programs and services, includes the purchase of three new school buses, and includes funding for debt service payments, salary increases for faculty and staff, and increases in employee benefit costs. The vote will be held from 12-9 p.m. in the district auditorium.

Spending under the proposal would decrease by 0.60%, or \$173,014, less than the current-year budget. The decrease in spending is a result of projected faculty and staff retirements, a slight decrease in debt service payments and removal of an appropriation for construction of a new concession stand that is currently underway.

"The proposed budget maintains programs and services in our schools while remaining fiscally responsible to district residents," Superintendent Patricia Morris said. "Our priority remains to provide high quality programs for our students and innovative professional development opportunities for our staff. We would be able to do so within the proposed spending plan."

District officials estimate that school tax rates, which are the amount of taxes

residents pay per \$1,000 of assessed property value, will decrease by approximately 0.29% for residents in the Towns of Stillwater, Saratoga and

Schaghticoke and 97% for residents in the Town of Easton, which has gone to full value assessment. Final school tax rates are set in August when assessment rolls are finalized. *(See page 3 for more about the tax rates.)*

If voters approve the proposed budget, the projected tax levy—the total amount of money a school district can raise through property taxes—would increase by 2.99%. This increase is below Stillwater's maximum allowable tax levy increase as determined by the state's tax levy "cap" formula (4.65%).

On May 17, voters will elect three members to the Board of Education to serve three-year

terms.

District residents will also vote on a proposed budget and trustees for the Stillwater Public Library. (See page 5 for more information.)

Greetings to the community...

On behalf of the Board of Education, I am pleased to present the 2022-23 budget that was adopted at our meeting on April 12, 2022. This year's budget total will be \$28,544,605. Again this year, the budget upholds the vision of the school district as well as the Board-approved district goals, which include student achievement, curriculum and instruction, safe learning environment, communication and community engagement, creating sustainable community partnerships and fiscal management.

As the Chair of the BOE Finance Committee, one of my goals for next year's budget was to have a 0% tax rate increase while maintaining our educational programs and making sure that our staff and teachers have everything they need to continue to ensure that our students receive a high quality education and maintain our infrastructure. I am pleased to say that through the leadership of the board and the administration, we have achieved that goal!

This year's budget continues the support of our current academic programs while adding:

- A STEAM program in the elementary school.
- An assistant principal position in the elementary school.
- Expanded Career and Technical Education, work-based learning, summer enrichment, and credit recovery opportunities for our students.

This budget also supports:

• Continued preventive maintenance programs that we have instituted for HVAC systems, boilers and equipment.

- Increased funding for diesel, gasoline and fuel oil for next year, and funding to purchase three new buses.
- Salary increases that were successfully negotiated with our teachers, plus increased costs associated with employee benefits.
- Continued funding for the \$100,000 capital outlay project. As I sit and write this, I reflect on how far we have come as a school and community during this time in the COVID pandemic. This school year started with our students coming back to in-person learning, wearing masks and COVID testing. There were many challenges surrounding these issues. The Board of Education is proud of our administration, teachers and staff because, even though there were some bumps in the road, they all came together to work through the issues to ensure student growth, learning and safety during these uncertain times.

Also, this year we had our first play in our newly renovated, state-of-the-art auditorium since the pandemic started and it was wonderfully done! Our varsity basketball team and our track students had big wins in their respective sports and we are very proud of their accomplishments. The new turf field was installed and we will be breaking ground for the new concession stand this spring! Our students are back and things are bustling again on our campus.

The Stillwater community has many things to be proud of and thankful for! We would also like to thank the community for their continued support of the school district and would like to remind you to please come out and vote on Tuesday, May 17, 2022, from noon to 9 p.m.

BUDGET

What's different in the proposed budget?

The 2022-23 budget proposal decreases spending by \$173,014, or 0.60% less than the current year. The 2022-23 spending plan includes funding for rising costs associated with salaries, employee pensions and benefits, as well as state and federal mandated programs and services. In addition, the proposed budget would fund debt service payments associated with the recent capital project and continue to provide for funding debt service payments from prior years projects.

TAXES

What is the difference between the tax levy and tax rate?

The tax levy is the total amount of money a school district raises in taxes each year from all property owners in the district. Tax rates are calculated by dividing the total amount of the levy by the total taxable assessed value in a community. Tax rates are affected by changes in both municipal assessments and state equalization rates, which are determined during the summer after the budget is adopted. The tax rate is used to calculate each individual property tax bill.

How would the proposed budget affect my taxes?

While the tax levy would increase by \$359,841 next year, total property assessments within the district are also growing, meaning there are more properties across which to distribute the tax levy. So, while the tax levy is increasing 2.99%, the projected tax rate decrease is approximately 0.29% because there is projected to be more taxable value sharing that cost. Actual tax rates are set in August when assessment rolls for the year are finalized. These rates are based on final property assessments (provided by each town) and equalization rates for each town, which are provided by the state Office of Real Property Services.

REVENUES

What is the district's maximum allowable tax levy?

State law limits the amount a district can increase its tax levy and still have its budget approved by a simple majority of voters (50% +1). Using a formula developed by the Office of the State Comptroller, Stillwater's 2022-23 maximum allowable tax levy limit is 4.65%. However, the proposed 2022-23 budget would increase the tax levy by 2.99%, or \$359,841, which is below the district's tax levy limit.

How does the Global Foundries PILOT affect the district's budget?

The Global Foundries PILOT (payment in lieu of taxes) continues to provide a guaranteed source of revenue for the district. The district is planning to receive \$1,355,000 through the PILOT in 2022-23. Although this is a decrease from the current year based on the terms of the agreement, the PILOT continues to provide revenue that supports programs and services for students.

VOTING

Why is there a vote for the Stillwater Public Library on the ballot?

On May 17, residents will vote on a separate proposition to approve the Stillwater Public Library budget and elect trustees. This is separate from the school district's budget. The library is seeking to increase its budget from \$309,400 to \$320,298, to support and maintain services. This money will be collected by the district and then forwarded to the library. The Stillwater Public Library has the same service boundary as the school district, however the library is not governed by the district.

What happens if the budget is not approved?

Under New York state law, if the school budget is defeated, the Board of Education typically has two options: put the same or a modified budget up for another vote on the third Tuesday in June, or immediately adopt a contingent budget. If residents defeat the proposed budget during a second vote, the Board must adopt a contingent budget.


Spring brings lots of activity

Elementary library refresh

Originally built in 1989, the elementary library is being updated and refreshed as part of a voter-approved capital outlay project to improve and maintain school facilities. Work includes new carpeting, updated furniture including tables, desks, chairs and shelving, and painting of the entire space, to make the library a more functional setting for student collaboration, problem solving, research and self-directed learning. Updates include an area dedicated solely to makerspace activities for individuals, small groups and classes, and more than 600 new books to provide students with a greater selection of characters and topics. The library has shifted from a space where students go solely to check out books to an engaging, innovative learning environment.

PROPOSITIONS & BOE ELECTION

Public Library proposition

Community members will vote on a proposition requested by and for the Stillwater Public Library to raise \$320,298, separate and apart from the annual School District budget, to support, maintain and fund the operating budget of the library. This money will be collected by the district and then forwarded to the library. The Stillwater Public Library has the same service boundary as the school district, however the library is not governed by the district. Voters will also be asked to elect three members to the library's Board of Trustees for at-large terms running from July 1, 2022, to June 30, 2025.

Board election

There are three open seats on the Board of Education. The "at-large" seats are for three-year terms to run from July 1, 2022, to June 30, 2025, to fill seats for which terms expire June 30, 2022. At the time this publication went to print, the final slate of candidates was not yet available.

CONCESSION BUILDING

In May 2021, voters approved construction of a concession building near the middle/high school athletic

field to provide a cleaner, safer, efficient and accessible facility for outdoor food service for student activities. The district has been using a tent and temporary storage trailer for this purpose. Work begins on the concession building this spring with a projected fall 2022 opening.


