

# Voters to decide on \$29.9 million budget for 2023-24 school year

# Proposed budget maintains programming; tax levy under 'cap'

On Tuesday, May 16, Stillwater Central School District residents will vote on a proposed \$29,988,245 budget for the 2023-24 school year. The spending plan preserves existing programs and services, includes the purchase of three new school buses, and includes funding for debt service payments, salary increases for faculty and staff, and increases in employee benefit costs. The vote will be held from 12-9 p.m. in the district auditorium.

Spending under the proposal would increase by 5.06%, or \$1,443,640, over the current-year budget. The increase in spending is being driven by increased salaries for faculty and staff; increased costs associated with health insurance and other employee benefits; and increases in utilities, diesel, gasoline and fuel oil.

"The proposed 2023-24 budget supports our vision to promote student success through continuous improvement while remaining fiscally responsible to district residents," Superintendent Patricia Morris said. "School safety and continued enhanced opportunities for students and staff remain our top priorities."

District officials estimate that school tax rates, which are the amount of taxes residents pay per \$1,000 of assessed

property value, will increase by approximately 1.93% for residents in the District. Final school tax rates

are set in August when assessment rolls are finalized. (See page 3 for more about the tax rates).

If voters approve the proposed budget, the projected tax levy—the total amount of money a school district raises through property taxes—would increase by 4.48%. This increase is below Stillwater's maximum allowable tax levy increase as determined by the state's tax levy "cap" formula (6.12%).

On May 16, voters will elect three members to the Board of Education to serve three-year terms.

District residents will also vote on a proposed budget and trustees for the Stillwater Public Library. (See page 5 for more information).

- The purchase of new buses.
- The \$100,000 capital outlay project.

# BUDGET QA

# What's different in the proposed budget?

The 2023-24 budget proposal increases spending by \$1,443,640, or 5.06%, over the current year. The 2023-24 spending plan includes funding for rising costs associated with salaries, employee pensions and benefits, as well as state and federal mandated programs and services. In addition, the proposed budget would fund debt service payments associated with previously completed capital projects.

#### TAXES

# What is the difference between the tax levy and tax rate?

The tax levy is the total amount of money a school district raises in taxes each year from all property owners in the district.

Tax rates are calculated by dividing the total amount of the levy by the total taxable assessed value in a community. Tax rates are affected by changes in both municipal assessments and state equalization rates, which are determined during the summer after the budget is adopted. The tax rate is used to calculate each individual property tax bill.

# How would the proposed budget affect my taxes?

While the tax levy would increase by \$554,267 next year, total property assessments within the district are also growing, meaning there are more properties across which to distribute the tax levy. So, while the tax levy is increasing by 4.48%, the estimated tax rate increase is approximately 1.93% because there is projected to be more taxable value sharing that cost.

Actual tax rates are set in August when assessment rolls for the year are finalized.

These rates are based on final property assessments (provided by each town) and equalization rates for each town, which are provided by the state Office of Real Property Services.

#### REVENUES

# What is the district's maximum allowable tax levy?

Under New York State law, the amount that the district can increase its tax levy is limited to a certain amount based on a tax levy limit calculation. Using a formula developed by the Office of the State Comptroller, Stillwater's 2023-24 maximum allowable tax levy limit is 6.12%. However, the proposed 2023-24 budget would increase the tax levy by 4.48%, or \$554,267, which is below what the law allows.

# How does the Global Foundries PILOT affect the district's budget?

The Global Foundries PILOT (payment in lieu of taxes) continues to provide a guaranteed source of revenue for the district. The district is planning to receive \$1,200,000 through the PILOT in 2023-24. Although this is a decrease from the current year based on the terms of the agreement, the PILOT continues to provide revenue that supports programs and services for students.

# Why is there a vote for the Stillwater Public Library on the ballot?

On May 16, residents will vote on a separate proposition to approve the Stillwater Public Library budget and elect trustees. This is separate from the school district's budget. The library is seeking to increase its budget from \$320,298 to \$348,757, to support and maintain services. This money will be collected by the district and then forwarded to the library. The Stillwater Public Library has the same service boundary as the school district; however, the library is not governed by the district.

## What happens if the budget is not approved?

Under New York State law, if the school budget is defeated, the Board of Education typically has two options: put the same or a modified budget up for another vote on the third Tuesday in June or immediately adopt a contingent budget. If residents defeat the proposed budget during a second vote, the Board must adopt a contingent budget.

Stillwater's athletic teams excelled in sports and the classroom, with several named NYSPHSAA Scholar–Athlete teams for earning an average of 90 or above.




#### Kara Moran medals at states

### **Public library proposition**

Community members will vote on a proposition requested by and for the Stillwater Public Library to raise \$348,757, separate and apart from the annual school district budget, to support, maintain and fund the operating budget of the library. This money will be collected by the district and then forwarded to the library. The Stillwater Public Library has the same service boundary as the school district; however, the library is not governed by the district. Voters will also elect four Library Board of Trustees members, three for at-large terms running from July 1, 2023, to June 30, 2026, and one for an at-large term running from July 1, 2023, to June 30, 2025.

#### **Board election**

There are three seats on the Board of Education for which terms expire June 30. 2023. Voters will elect candidates to the three "at-large" seats for three-year terms that will run from July 1, 2023, to June 30, 2026. At the time this publication went to print, the final slate of candidates was not yet available.

## **Rewarding achievement**

A day of free miniature golf and ice cream in June awaits middle school students who meet academic achievement goals. "Over my last seven years as middle school principal, we have promoted academic achievement by offering a special incentive at the end of the year," said Principal Timothy Hulihan. "There are three ways for students to qualify: earn an overall grade point average of 93+ for at least two of the first three quarters, improve their overall GPA by at least 5 points between the first and third guarter, or have zero absences during the first three quarters. The exciting news is that more than 74 students have already qualified, and every student is capable of improving their GPA in the third quarter to earn this reward!"




